How to Install your SSD?

Install in Desktop Computers

- Unplug the computer from the power outlet.
- Remove the computer chassis cover (please refer to computer manual for instructions).
- Connect the SATA and the Power cable from the motherboard to SSD(see the motherboard documentation for the placement of the cable connectors).
- Close the computer chassis and plug the computer to the power outlet.
- Turn on the computer.
